Why do Collective Impact Planning?

- An engaged citizenry is essential to healthy neighborhood and communities
- It includes the whole community in an effort to envision a greater future built around all aspects of neighborhood life—including, but not limited to, affordable housing, schools, parks, health care, child care, community safety, community building, social services, cultural amenities, and opportunities for economic advancement
- Place-based, Place-driven, Place-centric

What does a Collective Impact Plan DO/What is it?

- Through active community involvement, it yields a vision of what a neighborhood sees for its future
- Details clear goals to achieve that vision
- Articulates an action plan to reach those goals



How does it work?

- Community building creates relationships as resources
 - Asset Based Community Development approach
 - Engagement before Visioning
- Collective Impact Planning: A Social Contract
 - Formal and informal leadership engaged in the process
- Going Public



How does my organization fit?

- Convener role
- Partner role mutually reinforcing activities






Neighborhood Spotlight Process

- 2014: Technical Assistance and first neighborhoods selected
- 2015: First neighborhoods in process; Technical Assistance and second set of neighborhoods selected
- 2016: Second neighborhoods in process; TA and third set of neighborhoods selected
- 2017: Third set of neighborhoods in process







- Announcement of Neighborhood Spotlight program (12/20/13)
- Commitment to Change (via Survey Monkey)
- Kickoff of the Neighborhood Spotlight program (TODAY)
- Technical Assistance/Training sessions (REQUIRED) (bring your partners)
- LOI due 9/1/2014 for first round of neighborhoods

First Things First...

- Are you eligible?
 - Defined target geographic area of 4,000 to 25,000 residents
 - Applicant must be a 501(c)(3) nonprofit organization
 - Track record of collaboration with the public, private, and charitable sector to accomplish its mission and impact the community

 Broad community involvement in past and current strategies for organizational mission attainment

Matching Funds

- Is there a requirement for matching funds?
 - No DIRECT matching funds requirement of convening organizations
 - Office space, office supplies, phone and computer are required; grant funds may not be used for these

- Neighborhoods will be selected by Legacy Foundation committee
- Begin the work of collective impact planning in partnership with IACED



Selected Neighborhoods

- Hire a community builder (staff specifically dedicated to collective impact work)
- · Collective impact planning
 - Organize (including early action grants)
 - Decide
 - Act



Selected Neighborhoods

- Implementation of collective impact plans
 - Legacy Foundation may make funding available for strategies in the collective impact plans (projects and programs)
 - Not all projects will be funded by the Legacy Foundation
