Dean Andrew Frigo was born July 25,1989 and he passed away tragically in a car accident the sad morning of November 30, 2006, on his way to school. He was only 17 years old and a Junior Student at Lowell Senior High School in Lowell, Indiana. Family and friends described him as selfless, kind, loyal, and a friend to all. In his short time here, Dean positively impacted so many people and it continues today.

Since his passing, his mother Nancy Frigo Svetanoff and his sister Desiree Frigo Wood, have created the 33 RDP Dean A Frigo Foundation, hosted annual 5k walks, awarded over \$100,000 in scholarships to Lowell students, and recently opened an unrestricted endowment fund with Legacy Foundation that will "Pay It Forward" for years to come!

Grantee Spotlight TOWN OF NEW CHICAGO PARKS DEPARTMENT

Spring 2024 Transform Lake County Grant Recipient

Funding from Legacy Foundation assisted the Town of New Chicago Parks Department in successfully hosting year two of its Summer Lunch & Learn program. With additional help from town council members, River Forest food programs, and a new intern, they managed to serve over 52 households with children in grades K-12. Families who previously participated were more involved and past partners readily signed up to be involved.

New partnerships were formed, expanding the program's offerings to include more than 20 new activities this year! Attendees learned about

patterns in nature, food science, entomology, and so much more. Engaging the kids in hands on activities, like creating art to improve the park's aesthetic offered them an opportunity to learn how they could positively impact their community.

Owners of Individual Retirement Accounts (IRA), who are age 73 or older in 2024, must plan to take Required Minimum Distributions (RMD) annually.

To complete a QCD from an IRA to a charity, the IRA owner must:


- 1. Be at least age 70 ½ on the date of distribution.
- 2. Submit a distribution form to the IRA custodian requesting that the check be made payable directly to the charity.
- 3. Ensure that no tax withholding is being taken from the QCD.
- 4. Send the check payable to the charity directly to the charity or to the IRA owner to be forwarded to the charity.
- 5. Have the check clear the IRA by year-end.


